The need

The client required a module that enabled real-time tracking of assets for effortless management and utilization. It should allow for immediate visibility into the status and deployment of assets across the organization, which is critical for optimizing resource usage and reducing unnecessary expenditures.

There was also a demand for automating the auditing process to reduce the reliance on manual tasks. This would streamline the auditing operations, minimize the potential for errors and increase the accuracy of audit reports. Additionally, the client sought a method to track software licenses and related expenses to improve financial oversight and compliance.

The module included installing an inventory agent capable of collecting extensive data on each asset within the client's organization. The agent automatically documented important details such as asset specifications, locations, usage patterns, and maintenance schedules. By capturing this information, the system provided the organization with valuable insights into asset performance and operational status.

Infraon Assets also came with an automated process for bulk asset onboarding, which streamlined the integration of IT and fixed assets into the organization's existing inventory. It allowed for a faster onboarding of new assets, thereby reducing the time and labor involved in manual entries.

The module featured an advanced software license management system to track the allocation, usage, and expenditures, enabling the client to maintain compliance with licensing agreements and manage costs.
